III. Minutes

This report is based on making an accounting change to charge the \$25/month for Electricty at the RenCen to the Antenna Fund for the past 36-months. There was discussion on this issue, and the consensus was **not** to agree with this accounting change. Accordingly, motion **not** to approve the treasurer's report by Ben WB9FJO and seconded by Gary KC8VQX. Motion approved **not** to accept Treasurer's Report. The treasurer will issue a *revised* report in December.

The *net change* is +4 members for 2011 – for a total of **28** members in good standing. Members are encouraged to pay their 2011 dues at the 21-Dec-2010 meeting.

A total of \$160 in dues was collected and turned over to the treasurer.

VI. Tech Committee + Nets + ARRL Liaison

The 440 MHz repeater is running great!

Next step for 2m repeater is a party at the RenCen. We need to purchase at new connector for 7/8" hardline (\$50-\$100). 2m repeater will transmit w/ 25-watts with new connector. The amp for the 2m is the old Spectra – not good (too many spurs). Replacement cost will be \$300-500 (if we do not get satisfactory performance at 25 watts).

We need to tune-up the cavities for the 2m repeater – they are **worse** than the 440 MHz was. Who has a copy of the TDS forms for coordination of repeaters? The TDS forms [440 MHz and 2m] are overdue for submission to MARC.

Ray W8PIE is the *new* repeater trustee – replacing Jeff N8XN. Need MARC form to change repeater trustee to Ray W8PIE. Bobby N8CY will send a blank MARC TDS form to Ray W8PIE. We still need a *filled-in* TDS form with correct information to be used as a guide to submit new TDS forms to MARC. Does anyone have one?

VII. Old Business

VIII. New Business

Ben WB9FJO asked what are the specific plans for the 2m antenna?

- The Antenna will be custom made and "cut" to our frequency [146.910 MHz].
- We will use a CompRod Antenna (like 440MHz). Paul Reinhardt KC8DDT will assist in procuring.

Ray W8PIE noted that ½" hardline connectors are available on eBay for \$5.

Bruce KD8MFR inquired about the cost (and feasibility) to set-up APRS on the 2m repeater. It is not practical due to the requirement for an "open" internet connection – which we cannot have inside a GM facility.

Kurt WU8V asked if we desire to continue to allocate (e.g.) trunk swap funds to the Antenna Fund? Motion by Bobby N8CY to continue to allocate such funds to the Antenna Fund. Seconded by Tony W8OKX. Motion passed.

It was noted that the "female voice" on the announcements of the 440 MHz repeater is "dated", noisy, and needs to be changed. Several suggestions of names of "famous" persons (with a great voice) to replace existing announcements were suggested – James Earl Jones, Tim Allen, Jeff Daniels, and Norman Schwarzkopf. Bobby N8CY took on the assignment to find out if *any* famous person is willing to record a suitable announcement for us and report at the 21-Dec-2010 meeting.

Bobby N8CY had (3) kinds of terminals – (2) kinds of ring terminals and (1) kind of spade terminal. They were made available **free** to members. The response was *enthusiastic*, and most members availed themselves of the opportunity to acquire **free** terminals.
